Your strategic leadership will be pivotal in the integration of sustainable practices across all aspects of Tilt Renewables development, delivery and operations. Your vision, leadership, and expertise will be critical in advancing our commitment to environmental stewardship, social responsibility, and long-term resilience.

Your ability to collaborate, inspire, and lead by example will be instrumental in shaping our culture, living by our values and achieving our strategic goals. Foster a culture of sustainability throughout Tilt Renewables through engagement with our Board, employees, suppliers, and partners.
- Nature and Social Responsibility: Drive initiatives to reduce our environmental footprint, including nature impact strategies to achieve our Net Positive biodiversity target. Collaborate with the people and safety team and landholder management teams to implement social impact programs, the Diversity, Equity and Inclusion strategy, and community engagement efforts. Ensure ethical business practices and compliance with relevant regulations.



- **Risk Management and Climate:** Assess sustainability-related risks, such as climate change impacts, resource scarcity, and reputational risks and develop contingency plans to enhance organisational resilience to achieve our target of Net Zero scope 1, 2 and 3 emissions.
- Innovation and Research: Develop new strategic partnerships across technology innovations, research and biodiversity. Encourage innovation and pilot projects that drive positive change across biodiversity, community development, First Nations engagement and other key areas. Stay informed about emerging trends, technologies, and best practices in sustainability and renewable energy.
